Snippet of SHA constitution

- 1. Any group of not less than twelve members or persons eligible and intending to become members may be recognised by Central Council as a branch of the Association. The Central Council shall have the power to define the area covered by any branch.
- 2. Branches are expected to give 4 weeks' notice of their AGM and 2 weeks' notice of ordinary meetings. Following the completion of the 2017-18 electoral cycle in April 2018, all future Branch AGMs must take place between 12 and prior to the commencement of the national Central Council (CC) election process (i.e., between 12 and 3 weeks prior to the call for national CC nominations). Those elected as CC delegates at Branch AGMs are not permitted to stand in the national CC elections during the same electoral cycle though they can of course stand for national officer roles.
- 3. Branches are required to notify the Association of their AGM and of the names and addresses of their officers and to supply an annual financial statement.
- 4. If the business of a branch is not conducted in accordance with the constitution the Officers of the Association may take over the conduct of a branches affairs and its funds.
